Definition of Features/Services

Primary Listings: A primary listing is provided as a part of, and is included in the rate for, exchange telephone service.

Additional Listing: Additional listings are those listings furnished in addition to the primary listing.

Alternate Listings: Alternate listings refer a directory user to another telephone number during certain periods of time or when a called telephone is not answered.

Foreign Listings: A foreign listing is a listing in a directory of an exchange other than the one in which the primary listing is furnished.

Cross-Reference Listing: A cross-reference listing is a listing of the name by which the customer is commonly known to the public and includes a reference to the customer's other listed name.

Non-List: A customer's listing may be omitted from the directory (printed) but otherwise posted on the information records (411) and will be given out on request. This is referred to as non-listed service.

Non-Published: A customer's listing may be omitted from the directory (printed) but will be posted on the information records (411) without a telephone number. This is referred to as "nonpublished" service.

Extra Line Listing: An additional listing of a separate number under the main listing.

Directory Assistance: A telephone service used to find out someone's telephone number.
